Mr. Dougherty reviewed the Engineer's report with the Board. He stated the draft is complete for the Asset Management Plan that is now a requirement for obtaining funding. He and Mrs. Corson are in the process of reviewing the plan that is mostly using Mr. Toal's input from his O & M manual. He explained the DEP now requires all Authorities to have an Asset Management Plan for all projects and loan applications. A meeting will be scheduled to discuss funding of the various planned water projects whether it be private funding or NJEIT.

Operations Manager's Report:

The Board reviewed Mr. Toal's report. Mr. Buscher questioned the GPS requirement. Mrs. Corson said that she and Mr. Toal have a webinar scheduled for tomorrow regarding the DEP requirements and the software needed. She believes the deadline for implementing the GPS program is the end of October 2018. Mr. Dougherty said that the GPS information will be tied to the Asset Management Plan.

Mr. Buscher asked about the frozen water meter and what could be done to correct the problem. Mrs. Corson said that she and Mr. Toal did not think it was cost effective to make the correction at this time since the extremely cold temperatures this year which caused the frozen meters are not the norm.

Mr. Knott made a motion to approve the Licensed Operation Manager's report, seconded by Mrs. Burke. On voice vote, motion carried.

Executive Director's Report:

Mrs. Corson stated there was a watermain break at 2nd & Erial Rd on January 6th. Pioneer Pipe was called and agreed to do the work for \$8,000 not including the concrete. Work is planned to begin on Friday weather permitting. There was no charge for traffic control provided by the Pine Hill Police Department due to it being an emergency. Mrs. Corson reminded the Board that Reorganization is February 5th at 7:00 pm. There is a negotiation meeting scheduled for January 24th. Mrs. Corson said she spoke with Dave Patterson who said Amboy Bank's attorney does have the check and it will be released upon receipt of the signed amendment.

The difference between the original and amended is that the Authority agrees to reserve sufficient sewer allocation.

Mr. Odenath made a motion to accept the Executive Director's Report, seconded by Mr. Knott. On voice vote, motion carried.
